Scope of personal data processed

In case of bidding and concluding a contract

Protection of personal data

Only employees involved in evaluation have the right to access and control personal data.

VALILAB Ltd. keeps the personal data confidential. It does not make them available to third parties without the consent of the parties concerned or without legal authorization.

VALILAB Ltd. ensures the protection of the personal data with appropriate administrative, physical and logical protection measures, especially against unauthorized access, handling, transmission, disclosure, alteration, deletion and accidental destruction.

The data subject's rights

The data subject may request information on the processing of his or her personal data and may request the rectification or erasure of his or her personal data and the exercise of the right to object and complain.

Right to request information

The data subject may request information via the above email address that VALILAB Ltd.

- what personal information,
- on what legal basis,
- for what purpose,
- from what source,
- how long processes. and
- to whom, when, under what legislation did VALILAB Ltd. grant access to its personal data.

The request for information will be fulfilled by VALILAB Ltd. within a maximum of 30 days and will notify the contact person provided by the data subject.

Right to request a rectification

The data subject may request in writing the rectification of his or her personal data.

VALILAB Ltd. will fulfill the request within a maximum of 30 days and will notify the contact person provided by the data subject.

Right to erasure ('right to be forgotten')

The data subject may request in writing the erasure of personal data concerning him or her.

The request for erasure will be rejected by VALILAB Ltd. only if the further storage of personal data is required by law. If there is no such obligation, VALILAB Ltd. will fulfill the request within a maximum of 30 days and will notify the contact person provided by the data subject.

Right to restriction of processing

The data subject may request in writing the restriction of processing. The restriction lasts as long as the reason given by the data subject makes it necessary.

VALILAB Ltd. will fulfill the request within a maximum of 30 days and will notify the contact person provided by the data subject.

Right to object

The data subject may object in writing to processing if VALILAB Ltd. uses his or her personal data for other purposes than purposes published in this document.

VALILAB Ltd. will respond to the objection within a maximum of 30 days and will notify the contact person provided by the data subject.

Right to lodge a complaint

The data subject may seek legal redress if he or she considers that VALILAB Ltd. processes his/her personal data unauthorized, improperly or not for the purposes described in this document.

In the context of the remedy the data subject may:

- file a complaint directly with VALILAB Ltd.,
- lodge a complaint with the supervisory authority, or
- go to court.
